## **COMMISSIONER'S** CORNER

It's been a busy time at the NC Department of Insurance, as we are approaching the final quarter of 2024

The various departments within DOI have been reporting on the many ways we are continuing to help North Carolina residents and protect consumers.

Fighting fraud has been a major focus of the department recently, and our CID agents in the Fraud Control Group have worked tirelessly to keep the bad guys off the streets and to raise awareness of the havoc fraud can cause and how the public can stay away from costly scams. Scams are everywhere!

This year we have been traveling around the state for our Fraud Town Halls getting the word out about its impact on our state. So far we have visited Leland, Rockingham, Hillsborough and Elizabeth City and are planning visits to Wilson and other locations later this year.

It is an important endeavor. Insurance fraud costs Americans over \$300 billion annually, according to the Coalition Against Insurance Fraud. That's between \$900 and \$1,000 for every American or nearly \$4,000 for a family of four. We will continue to deliver the message about the dangers of insurance fraud and scams and fight it with all of the resources we have.

I've also been working on behalf of consumers to help keep insurance rates down.

In June, I negotiated an average statewide 8 percent dwelling rate increase for North Carolina.

This increase is 42.6 percent points lower than the 50.6 percent increase requested by the NC Rate Bureau. I was happy that we were able to save North Carolina consumers more than \$151.7 million per year in this rate case over what the insurance companies requested. The new rate will take effect on Nov. 1.

Unlike homeowners' insurance, dwelling insurance is primarily offered to nonowner-occupied residences with four or fewer units.

In February, I said "No" to the insurance companies' average 42.2% proposed increase in homeowners' insurance rates. We've set a court hearing date for Oct. 7 on this matter.

I also said 'No' to a proposed increase in mobile homeowners' insurance rates requested by the rate bureau and have set a hearing date for April 7, 2025.

## MEDICARE OPEN ENROLLMENT

Medicare Open Enrollment Period (OEP) runs from Oct. 15th through Dec. 7th each year. During this time, people with Medicare can review features of Medicare plans offered in their area and make changes to their Medicare coverage, which go into effect on January 1st of the following year. These changes include switching from traditional Medicare to a Medicare Advantage plan (or vice versa), switching between Medicare Advantage plans, and electing or switching between Medicare Part D prescription drug plans.

Medicare beneficiaries are encouraged to review their current coverage during the annual open enrollment period and compare other options that are available where they live. Because an individual's medical needs can change over the course of the year, and from one year to the next, this may influence their priorities when choosing how they want to get their Medicare benefits. Medicare Advantage and Medicare prescription drug plans typically change from one year to the next and may vary in many ways that could have implications for a person's access to providers and costs.

## In the complex world of insurance, it is essential for professionals to stay informed about the Legislative updates that impact their industry, such as N.C. Senate Bill 319 which was signed into law by Governor Cooper on July 2, 2024. This Bill repealed

N.C.G.S. § 58-33-26(p), effective July 2, 2024. That statute had previously stated:

"An individual shall not simultaneously hold an insurance producer license with casualty, personal lines, or property lines of authority and an adjuster's license in this State. An individual who holds an insurance producer license with casualty, personal lines, or property lines of authority may apply for an adjuster license without having to take the adjuster examination in G.S. 58-33-30(e) if the individual applies for the adjuster license within 60 days after surrendering an insurance producer license with casualty, personal lines, or property lines of authority. An individual who holds an adjuster license may apply for an insurance producer license with casualty, personal lines, or property lines of authority without having to take the casualty, personal lines, or property insurance producer examination in G.S. 58-33-30(e) if the individual applies for an insurance producer license with casualty, personal lines, or property lines of authority without having to take the casualty, personal lines, or property insurance producer examination in G.S. 58-33-30(e) if the individual applies for an insurance producer license with casualty, personal lines, or property lines of authority within 60 days after surrendering the adjuster license."

With the repeal of that statute, an individual may now simultaneously hold an insurance producer license with casualty, personal lines, or property lines of authority and an adjuster's license. However, the repeal also took away any examination exemption.

As a result, if an individual decides to add an adjuster license in North Carolina, they must meet the examination requirement set forth in **N.C.G.S. § 58-33-30(e)**. If an individual decides to add an additional line of authority for casualty, personal lines, or property to their North Carolina insurance producer license, they must meet the fingerprint and background check, pre-licensing course(s), and examination requirements for that line of authority. License applications are entered online at <u>www.nipr.com</u>.

It is important to mention, however, that this recent legislation did not impact the regulation pursuant to N.C.G.S. § 58-33-70(b):

"On behalf and on request of an insurer by which an insurance producer or limited representative is appointed, the insurance producer or limited representative may from time to time act as an adjuster and investigate and report upon claims without being licensed as an adjuster. No insurance producer or limited representative shall adjust any losses where the insurance producer's or limited representative's remuneration for the sale of insurance is in any way dependent upon the adjustment of those losses."

Another change which was impacted by the signing of N.C. Senate Bill 319 was to **N.C.G.S. § 58-33-40(e)**, which prior to July 2,2024, read as follows:

"An appointment shall continue in effect as long as the appointed insurance producer is properly licensed and the appointing insurer is authorized to transact business in this State, unless the appointment is cancelled."

After July 2, 2024, this was rewritten to include the following:

"Notice of the cancellation may be submitted to the Commissioner by either the appointing insurer or appointed insurance producer."
